CALL FOR PRESENTATIONS

We are requesting applications that will:

- Address the issues and challenges of opioid treatment
- Provide information on how to develop and/or enhance the skills of practitioners providing treatment
- Contribute to the adoption of evidence-based principles and practices within opioid treatment

Conference Objectives

- To identify and provide new information of critical importance to the field
- To examine and evaluate the implications of new information for clinicians, administrators and policy makers
- To demonstrate techniques for improving clinical and program administration

Suggested Workshop Topics

- Tobacco Cessation in OTPs
- What are the key outcomes for OTPs and how are they measured?
- Staff training and attitudes for promoting best practices and optimizing treatment outcomes
- What factors create and sustain a therapeutic environment in OTPs and therapeutic relationships between clinicians and patients in those clinics?
- The role of patient and family advocacy for Medication Assisted Treatment (MAT)
- The interface between OTPs and child welfare service organizations
- Determining the role of methadone in accidental drug deaths – what are the limitations of forensic science in this issue?
- Methadone and cardiac conduction – what do we know and how should OTPs respond based on that?
- Improving patient care within budget realities
- Emerging populations: younger pharmaceutical opioid addicts; aging patients
- Integrating buprenorphine in OTP practice
- Patient-centered care – MAT is more than just medication

Workshop presentations are 90 minutes in length. **Workshop presentations *may not* include more than three speakers.** In some instances, the Workshop Committee may suggest combining presentations similar in content into one workshop.

1. Please visit the AATOD website at www.aatod.org and follow the on screen instructions for submission.
2. All submissions **MUST** be submitted using the parameters specified. Include all appropriate corresponding attachments and handouts. Materials must be high quality for duplication; fax copies are not acceptable.
(This information is requested for inclusion in continuing education applications.)
3. The following items must be completed **ONLINE** (www.aatod.org) for all submissions:
 - a. Completed Call for Presentations Submission form
 - b. Recent CV for each Presenter listed (Note: The CV must include your highest earned degree, the institution awarding the degree, and the year the degree was awarded in the area of specialization)
 - c. Completed Author's Agreement
 - d. A short bibliography for the entire workshop
4. Deadline for receipt of Call for Presentations is **JUNE 27, 2008.**
There are NO exceptions to this deadline date.

INSTRUCTIONS FOR PREPARING A POSTER PRESENTATION

Please visit the AATOD website at www.aatod.org and follow the on-screen instructions to submit a poster presentation for consideration. Upon acceptance, use these guidelines for preparing your poster for presentation on-site at the conference. Your poster presentation should contain succinct headings that organize and logically display the information. Graphics should be explicit and brief. Elaboration is best done verbally, just as if it were an oral presentation using slides.

The poster display should focus on:

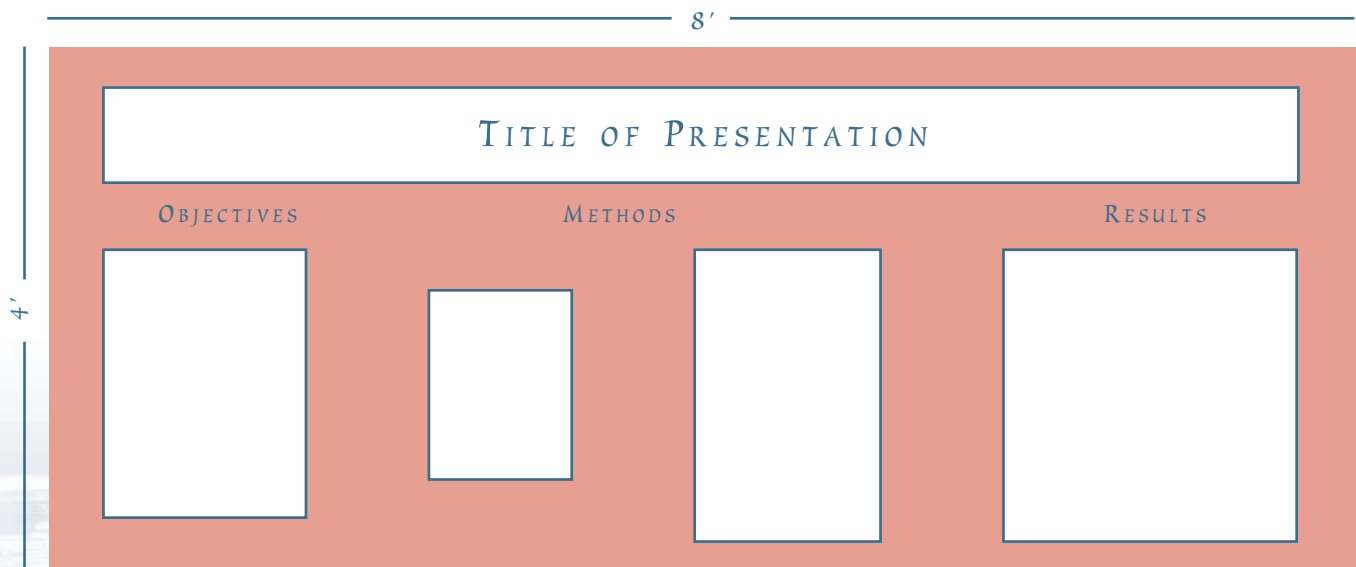
- Hypothesis or Objective
- Methods
- Results or Outcomes

The working area for displaying each poster presentation is four (4) feet high and eight (8) feet wide less a two (2) inch frame on all four sides. The surface is fiberboard contained within the frame and firmly supported on "A frame" legs. Including the supporting legs, the display stands a total of six and a half (6 1/2) to seven (7) feet high.

All illustrations should be made up beforehand. Keep illustrative material simple. Illustrations must be read from distances of approximately three (3) feet or more. Charts, drawings, and illustrations should be similar to those that would be used in making slides.

Prepare and bring to the meeting all illustrations needed for your presentation – figures, tables, diagrams, equations, etc.

The Workshop Committee will notify you if your poster presentation has been accepted. Please be prepared to bring poster materials to incorporate the following format.

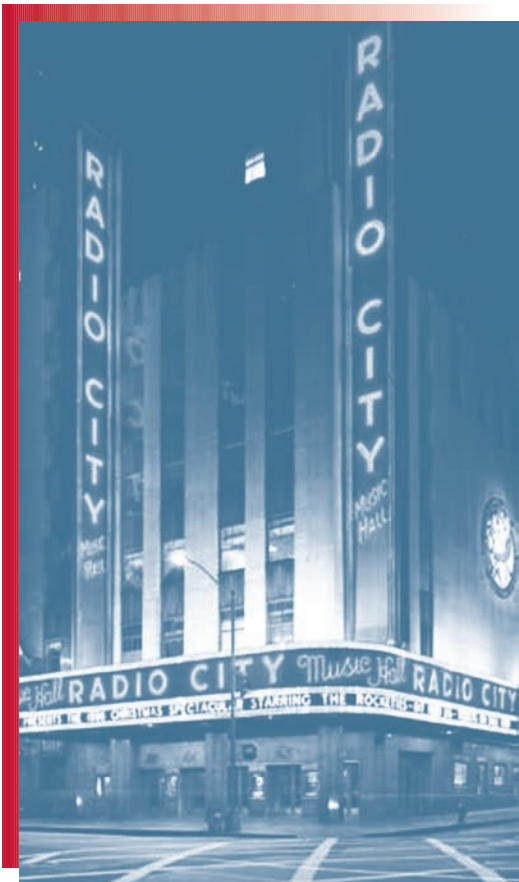
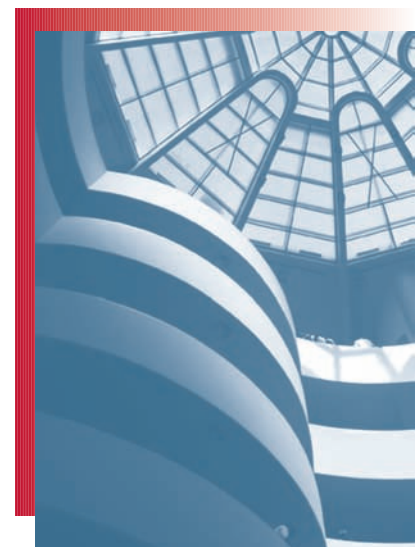
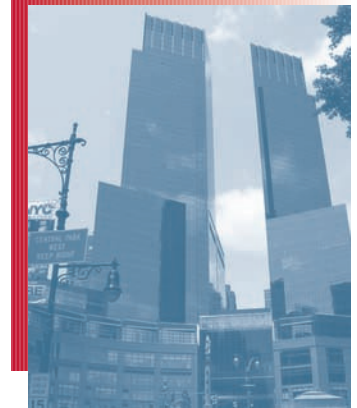
